On August 12, 2022, the OPO received an email complaint.

**The complainant alleges:** After sending this email to detective [REDACTED], he spoke to the perpetrator [REDACTED] showed no evidence and decided he's going to go with him. Moving me he stole two items [REDACTED] moving company my \$300 ladder and my \$2,700 medical ramp.

Once reporting it I had to go through

And my \$2,700 but turn in my ladder two days after moving me but still have not returned my \$2,700. ladder I tape that conversation with [REDACTED] [REDACTED] was supposed to send some money due to her workers [REDACTED] [REDACTED] stealing my Ramp for \$2,700

Mediation with attorney [REDACTED] whereby [REDACTED] [REDACTED] moving employee agreed to pay half on [REDACTED] and when the mediation attorney [REDACTED] tried to contact her she never returned the call after saying she would make a settlement in [REDACTED] weeks and that was [REDACTED]
