NOTICE OF COMPLAINT

On August 30, 2022, the OPO received an email complaint.

The complainant alleges: ai co and he APD are conspiring to make me homeless. i was wrongfully evicted from the very trashy [REDACTED] motel by APD officers who categorically threatened to arrest and institutionalize me even though my rent was current and i was negotiating a lower price due to amenities that weren't provided. they put me in a room without AC, the fridge was inoperable, they infested the room with bed bugs. see attached complaint.

[REDACTED] is sending officers with fake names to respond.

i was wrongfully trespassed off the property and constantly threatened with arrest and institutionalization.

indeed one of the offices threatened to kick in the door and arrest me.

i'm sorry you people are complete and total lunatics who lie at every turn.

[REDACTED] is trying to make me homeless to prevent me from pursuing legal remedy against [REDACTED] in the courts and in the intelligence community.

you people on this email are amoral, criminal, and shameless.

APD complaint [REDACTED] they conspired with the [REDACTED] (weekly) to unlawfully evict me. this weekly hotel tried to illegally overcharge me \$340 when the rate is \$320, they purposely deprived me of amenities, they refused to provide AC and neglected the fridge, they coordinated w/ [REDACTED] to infest the bed w/ bed bugs, then didn't treat appropriately. tx affords lower rate for denied amenities. they didn't provide a peephole, or post the rates as per law. APD arrived due to refusal of lawful lower rate and threatened to arrest me and kick down the door (they had no warrant). i had been there over [REDACTED] days therefore they have to go through housing court. i showed receipts as proof. APD then said i have until [REDACTED] [REDACTED] to vacate. i told the [REDACTED] hotel i would litigate. the [REDACTED] hotel retaliated by disabling the

AC and when i left the room to address it with them, they illegally locked me out. APD [REDACTED] (red head meaning [REDACTED] for accused spying operative [REDACTED]) responded and stated i was criminally tres-passed off the property. overreach. it was unlawful lockout. violation of due process - denied housing court right. i was forced to leave that night and was made homeless. these AP names are fake & the responses are designated, not randomly assigned - since the incipient in [REDACTED]. i have multiple court actions in JPs travis co -they rocket docket my mater against [REDACTED] (who didn't answer or showup for court) [REDACTED], then tell me my matter to retrieve mystolen property from dirty landlord [REDACTED] takes 4-6 months, as well as my matter in jp1 against [REDACTED] a travis co & [REDACTED] fronted county support fake transitional housing entity. [REDACTED] sub-mitted no response to my claims against dirty [REDACTED] operatives [REDACTED]. at all. jp2 ruled dismissed w/ prejudice against [REDACTED] [REDACTED]. unheard of. this is a campaign of hierarchical and stratified corruption to muscle & prevent me from pursuing my information submitted to the intelligence community against [REDACTED]. they are trying to force me into homelessness & deprive me of court remedy. the people at the [REDACTED] hotel refuse to say their name on camera.

This notice of complaint is a request for Internal Affairs to initiate an investigation to determine if the employee conduct is within compliance of APD policy, Civil Service Rules, and Municipal Civil Service Rules.
