Complaint: <p>officer Frank Corpus opened a stalking case several months ago in which I was individual associated with the accusatory actions (the potential stalker). officer corpus found a phone number associated with me, somehow, called it, spoke perhaps with my father and went on to dictate that he had spoken with me.</p> <p>it is several months later and today I called officer Corpus personally to ask him if my father had misled him and said he was me when he made the aforementioned phone call; it is important to me personally, because there is now an active criminal stalking case in which I am the defendant.</p> <p>officer Corpus immediately was abrasive verbally, with confrontational tonality and was demanding and overall extremely dismissive of my phone call as we spoke for roughly 1 minute about this matter.</p> <p>due to officer Corpus' direct involvement with shutting down my phone call so antisocially, I am choosing to report his excessively unfriendly demeanor/behavior, and I'd like to posit that it may be possible the officer lied intentionally in his case documentation as he most certainly NEVER called or spoke to me at any point before today.</p>

Complaint: This complaint form contains file attachments. Location: 6900 Brodie Ln. 3600 William Cannon Dr. Ofc description: Female, AP7791, brown hair, short stature Officer Rast was assisting a driver whose car had stalled in the right lane of traffic. I was in the right lane at first, but moved into the middle lane to pass the stalled vehicle. As I passed, I saw that the police vehicle was positioned behind the stalled Ford Expedition, touching the Expedition with her front guard. The officer was in her vehicle when I approached and seemed to be attempting unsuccessfully to push the Expedition. When I got up to the patrol car, Officer Rast was exiting her vehicle and walking up to the front driver side of the Expedition. She was still at the Expedition as I passed. The light turned green, and I attempted to get in front of the Expedition to turn right. It was at this moment that Officer Rast began to push the Expedition, hitting my vehicle from behind. I turned right, then did a U turn to come back to speak with the Officer. I saw the Officer pushing the Expedition across 7-8 lanes of traffic during rush hour traffic. We pulled into the Walgreen's driveway. The Officer asked for my license and proof of insurance and asked the same of the other driver. The Officer then went to her vehicle, without speaking to either of us. After about 20 minutes, the Officer handed us both our IDs, insurance, and a print out, which said "Accident Information Exchange." Upon reading the report later, I realized that the Officer had only included her account in the Accident Report. She did not include herself in the involved parties. The report was barely comprehensible, and did not accurately describe what happened. I called later to refute her account. When she called back, she was very dismissive and told me that I was completely at fault. This was not her judgement call to make. I had the right to /make a statement in this case. She should have called another officer to take down our accounts, so that the accident report was unbiased.	





Further, she should not have been trying to push a large vehicle across 7-8 lanes of traffic without any assistance from other officers. There should have been another officer directing traffic. What she did was reckless and could have resulted in a much larger accident.

When I went back to the scene, I did realize that the bike lane turns into a right turn lane right where they were parked. The officer claims that she had her arrow lights on pointing to direct other cars to the left or right; however, I did not see those lights. The right lane was a narrow bike lane at the point where I moved into the left lane. If it had not turned into a right turn lane next to where the Expedition was parked, she would have been totally at fault.

My complaints are that 1) Officer Rast put others in danger by trying to move the vehicle by herself in such a reckless manner and 2) Officer Rast made a biased police report which ensured that she would not be found at fault for the accident. I was going to let it go. My insurance paid for the other vehicle's repairs, and I did not contest it. However, the other driver is now claiming that they and their passenger were injured. They were injured due to Officer Rast's negligence in this situation.

Complaint: <p>This incident occurred at "[REDACTED]" apartment complex at apartments 820 with my client and Ms. [REDACTED]</p> <p>I was on the telephone with a client who had called in a complaint to APD regarding her neighbor, [REDACTED] who had been alternatively making threats of death against him and his other neighbors that live in the apartment adjacent to Ms. [REDACTED] - or claiming that then staying at her apartment were sex traffickers. He was ready to press charges and stated that his neighbor also wanted to do so.</p> <p>When APD arrived my client had been scared so I was offering emotional support while he waited. When they arrived after several requests for his name and badge number he eventually said he was "Officer Pats" and again only after prompting gave his badge # as #7623.</p> <p>He was accompanied by "courtesy officer" Connor from the apartment complex. Officer Pats went to Ms. [REDACTED] apartment and briefly spoke to her but not the men. Ms. [REDACTED] has been inpatient in Austin Oaks Psychiatric Hospital and had been released along with the men earlier that day supposedly due to a "bed shortage" though at the mental health court hearing I attended 45 days was the recommended stay. Ms. [REDACTED] was in the lock up. for the 2nd time in a month due to death threats against neighbors, walking around the apartment complex with a stun gun stating she would kill neighbor named [REDACTED], as well as assault against a Metropolis manager.</p> <p>Officer Pats, after talking to Ms. [REDACTED] proceeded to leave without talking to my client or the other neighbor. They literally ran after him stating that they wanted to make a police report. Officer Pats would not acknowledge them and drove away.</p> <p>This is unconionable. While its true I only heard this incident, I clearly heard "Officer Pats" and "badge 7623." I also heard his exit and my client pleading for help. I timed it at 22 minutes start to finish.</p> <p>I hope this officer will be reprimanded for his unwillingness to take a police complaint from a victim of harrasment and death threats. I am told that APD frequently takes up to 30 minutes longer to respond to "The Metropolis" residents and staff and that once there they take very little</p>

time, will not listen to residents or staff and that management and residents have been told "They (the residents) are always hurting each other." as if there is no way to help.

There is a way. Respond as you would in my white middle class neighborhood - as all Austin citizens should be served by our police department.

Complainant's daughter had a two-year-old daughter. APD knew the complainant was the mother and grandmother. ██████ handed the phone to APD Officer Yaletchko, badge number 8132. The officer told the complainant her daughter was dead, and she needed to get her granddaughter and asked how far away she was. She told the officer she was 45 minutes away. The complainant heard the officer tell the other officers that she was too far away, and they needed to find out where to put the child. She asked ██████ to give the officers back the phone so she could give the officer her number, but ██████ told the complainant he would give her the granddaughter if they gave her to him and then hung up the phone. Her granddaughter has a different father and has never been around ██████. The daughter and ██████ have other children together. The officer never got the complainant's name or phone number. When the complainant got there everyone had left and there was no one there to tell her how her daughter died or where she was. There was a police officer on patrol, but he could not tell her anything. The complainant waited for over an hour for victim services to arrive. The person from victim services, Cody Mitchell, badge 4797, told her he was sorry for her loss and gave her a victim information pamphlet and started to leave. The complainant asked him where her daughter was and what happened to her. Cody told her he was not a police officer and did not have that information. The complainant asked where her grandchild was, and Cody told her she was with ██████ and he was going to give the baby to her. The complainant told Cody when ██████ answered her call, he told her he was not going to give the grandchild to her. Cody told the complainant CPS did a background check and determined it was ok for him to have her. When the complainant asked for the contact for CPS Cody told her he did not feel comfortable providing her with that information. The complainant told Cody they should have never given the granddaughter to ██████ because he has a restraining against him for being abusive to her daughter and he beats his own children. Cody told the complainant to give him ██████ number and he would call him. He was gaslighting her. When Cody got off the phone, he told her that ██████ was not going to give her the child and if she went over there, she would be arrested. IA got in touch with the complainant and told her they were not involved in the situation and did not know what was going on. If they had been involved, they would not have handed a child over to someone they did not know, and that the child would have been turned over to CPS. The complainant is not going to stop until she gets her grandchild back. She keeps calling but APD is</p>

On Wednesday, 4/19, she spoke to a detective regarding her case and the detective told her he has never received any messages from her. The detective also told the complainant that the daughter was released to Aubrey, her daughter's oldest daughter who is only [REDACTED], which is not true because the daughter was released to her deceased daughter's ex. The story keeps changing. APD is changing the story to protect themselves. When she asked the detective for her daughter's phone, purse and keys so she could take care of her daughter's estate the detective told her no, those things were being released to her daughter's oldest daughter and then he hung up the phone. The whole situation was handled so wrong.
