NOTICE OF COMPLAINT

On September 19, 2022, the OPO received an online complaint.

The complainant alleges: i was wrongfully trespassed off the property of [REDACTED] at [REDACTED] by [REDACTED]. the staff would not give me a fork.

[REDACTED] is coordinating w/ [REDACTED] to harass me with passive-aggressive behavior. they make my drinks incorrectly, an asian employee at [REDACTED] had make-up applied & claimed to be in a fight with a black eye - they shadow me situation. i did absolutely nothing wrong at this [REDACTED] i did not harass anyone. there is a lengthy history of APD wrongfully issuing criminal trespass against me for political purposes. this is not an isolated incident. the legal definition of harassment is you must be told it is harassment and if the conduct doesn't stop then it constitutes harassment. this is a completely dishonest, manipulative [REDACTED] employee who is coordinating w/ a criminal spy hired by [REDACTED] to harass me. she unjustly called 911 on me & falsely accused me of harassment when she was passive-aggressive and lying that they didn't have a fork. i told the officers i had the whole incident on video and they didn't ask to view it and gave no consideration to my side of the story. they also threatened to arrest me several times with no legal standing. who knows if these are real officer names or not.

[REDACTED] has sent officer [REDACTED], and [REDACTED] to respond to incidents i surrounding me. [REDACTED] APD lying that cameras are down at [REDACTED] & wrongfully issuing criminal trespass [REDACTED] i was told by Corrupt officer [REDACTED] that a detective would contact me regarding the [REDACTED] employee assaulting me & no one ever did [REDACTED] additionally i was wrongfully issued a criminal trespass from the [REDACTED] by fake APD officers when i was wrongfully evicted there. [REDACTED] deprived me of amenities i paid for (AV, fridge & they coordinated w/ [REDACTED] to infest the bed with bed bugs & didn't properly treat) rent was current. APD arrived threatened to kick down the door, arrest me, and institutionalize me. APD agreed i could vacate the next day, then the [REDACTED] deliberately cut the AC and when i went to address it with them locked me out altogether. APD had to return & they

wrongfully trespassed me off the property. rent was current & i had been there over 30 days. the laws & evidence support me. APD is corrupt. APD is disgraceful.

This notice of complaint is a request for Internal Affairs to initiate an investigation to determine if the employee conduct is within compliance of APD policy, Civil Service Rules, and Municipal Civil Service Rules.
