NOTICE OF COMPLAINT

On July 18, 2022, the OPO received an email complaint.

The complainant alleges: APD contacted me regarding report [REDACTED] and told me to file it online at the APD at the APD online reporting system.

APD then went in and disallowed flow through of my online complaints.

see attached "technical difficulties" message.

the spy tells them my IP address and APD goes in and disallows flow through.

[REDACTED] and APD leadership are completely corrupt.

these people do not belong in their positions.

APD reports [REDACTED]

[REDACTED] need to be reinstated immediately.

further [REDACTED] spy left a dead rat for me on the way to the bus stop by the [REDACTED] where i worked at [REDACTED], Austin, TX [REDACTED]

additionally [REDACTED] coordinated with [REDACTED] to drop a dying bird on my cash register station and have a latino man take the still responsive bird claim it needs water, walk away, then return and claim the bird had somehow died within these few minutes.

i worked at [REDACTED] as a volunteer in the [REDACTED] clinic and regularly interacted and treated afflicted animals and saw end of life behavior. this baby bird was responsive. it was lifting its head, opening its mouth, its eyes were open, it was trying to lift its wings. this man killed the bird to threaten me on behalf of [REDACTED] and [REDACTED] and [REDACTED] who i have legal action against in the corrupt JP2.

[REDACTED] and [REDACTED] of the [REDACTED] [REDACTED] refused to provide transportation to the "food pantry" for me or allow me access to the clothing closet.

[REDACTED] wants to select clothes for me and diminish bags of food for me by refusing to facilitate a social worker taking me to and from the "food pantry"

i live at [REDACTED] - the food pantry is maybe 5 minutes away.

why do i say this?

because the city of austin [REDACTED] was abusive in their position to me, then gave me 1 bag of food as opposed to the 3-4 they're supposed to give.

fake name "[REDACTED]" assisted me? i received a call from [REDACTED] regarding the matter - however we never connected as she didn't return my call.
