NOTICE OF COMPLAINT

On August 15, 2022, the OPO received an online complaint.

The complainant alleges: The Austin police department was recently sued for mishandling an assault case. In a major case in which 19 victims came forward. I want to file for Gross Incompetence for the mishandling of a case the police heinously trying to set me up into. I blatantly didn't even almost do what they're now trying to force. Every single one of my civil rights are being violated and I have documented evaluations to prove it. I am being attacked by the police incited mob that is trying to send me to jail based solely on malice. No one here has ever even heard of me. I live an hour and a half away. I literally do not know know any of these people nor do they know any thing they're attempting to talk about. This is a random mob of people with a mob mentality one sided in a bogus ATTACK on my body. I menstruate, have a reproductive system, and 23 XX chromosomes. I am genetically, mentally, and spiritually a girly girl. It is my passion. I have worked hard to put myself through college. My original birth certificate says I am a girl. Austin pd has a satellite assaulting my body and I have legal proof of it. I have been proven to be mentally sane. The police force is forcing fake statements which is impossible for me to follow because I am working a full time job. This is an obsessive attack on me that they want to be personal. I am not narcissistic in any way. I am heterosexual. I am a Christian only. I stand up for justice unbiasedly. I have not committed any crime. I blatantly purposefully didn't touch anyone's genitalia ever. They have become obsessed with my innocence because I have defended my self against their multiple confirmed volatile sexual assaults to my body. I have proven this over and over and also in a court of law. The police are corruptly using jealousy from unknown local females to attack me with random malicious untrue statements. The police created a false narrative of a stranger claiming they randomly knew I was an orphaned rape victim. 1 in 6 women are. They then said they're going to "put it all on [me]". I am far younger than the assailants who have also admitted what they have done. Polygraphs need to be issues to these older people as well as police. They are withholding suspects. The police are maliciously using malicious people who are clearly conspiring against me. The police are threatening anyone who does not align with their agenda against me. Many people love me and vouch for me. The others know their older children were doing these things to me who was much younger. They are trying to

conspire using lies as these people who are using false claims of love towards are only maliciously trying to get their kids off for what they know they were doing. They have vowed to lie with an indifferent tone. The police have corruptly said verbatim they are going to make it so:” its all going to be on her”. Falsely claiming thats the easier angle. They were doing these things to me not the other way around. The police are using bullhorns to say the going to disregard the truth in that they’re going to keep violating my rights to set me up into crimes I have never committed. I am naturally comfortable and happy as a woman these made up caricatures aren’t who I really am. Its unrealistic for them to even claim anything would indicate to the contrary to the intellectual woman I have always strived to be on my own. They have even threatened in two counties now to have me sexually assaulted in jail. They have been encouraging the public to kill me. Someone even shot a bullet through my grandfather’s house while we all were in it next to my head. The police made that up in retaliation to attempt to justify what happened on [REDACTED] [REDACTED] when a male officer put his hands on my naked body as I am female. I have concrete evidence against the lies being told by investigators.

This notice of complaint is a request for Internal Affairs to initiate an investigation to determine if the employee conduct is within compliance of APD policy, Civil Service Rules, and Municipal Civil Service Rules.
