NOTICE OF COMPLAINT

On May 31, 2022, the OPO received an email complaint.

The complainant alleges: Officer [REDACTED]. I reported concerning me almost being raped and it took him [REDACTED] days to come out here's the complaint number on him [REDACTED] [REDACTED] he was called that one something this morning on [REDACTED] he's banging my door down I have it on tape conversation and he never went to apartment [REDACTED] I think it's time to go to court first of all I'm telling him what he did when the maintenance man tried to rape me this is why this complaint is on him and he said he came right out after 911 call but the attempted rape of sexual assault with the maintenance man happened on [REDACTED] [REDACTED] he didn't show up until [REDACTED] [REDACTED] that is why I found the complaint and he came in my bedroom and got caught in my drawers and inside my closet with his body camera I have him on tape conversation the next day making him aware I reported him and he didn't deny what he did I still have all those tapes I have the tapes from this morning of Officer [REDACTED] showing up but we go through the rape conversation of the maintenance man and then he lets me know he never knock on apartment [REDACTED] on Cape conversation but he comes to minds and damn near kicking in when he was dispatched at one shop needing show up until [REDACTED] something this morning [REDACTED],

Again case number on him is [REDACTED] I'm going to call the FBI because first of all he's trying to even cover up for showing up [REDACTED] days later of an assault of a sexual assault and the attempted rate with the maintenance man but then he's on tape again this morning telling me he was dispatched at [REDACTED] something but he didn't show up till after [REDACTED]. this morning damn near kick it in my door and I have it all on tape conversation and the whole conversation

Police oversight complaint [REDACTED] I have the tape conversation of him just leaving and I'm going to save that because I think it's time we go to court because I believe he really came here to let me know that he's still a police he had no intentions of dealing with the disturbance of apartment for [REDACTED] I have tenants on tape conversation also complaining with this lady have been doing [REDACTED] who have two people living with her that's not on the lease since [REDACTED] a section 8 fraud and a many complaints on this lady but you send this man

here that tries to undermine my conversation and tell me he was here for the rape but came [REDACTED] days later. 911 call dispatched officer [REDACTED], at [REDACTED] something this morning he didn't show up until after [REDACTED]. and he said he never locked knocked at apartment [REDACTED] he stood outside her door he came to mind thank God I taped it he's banging my door down and we discussed what happened proud that I have complaints on this office. I gave officer [REDACTED], complaints case numbers of everything going on stormy from 311 case number [REDACTED] for apartment [REDACTED] disturbing the peace number [REDACTED] another case number [REDACTED] and do a officer [REDACTED] case number [REDACTED] report number [REDACTED] concerning attempted rape by the maintenance man at [REDACTED] apartment that happened on [REDACTED] officer [REDACTED] badge number [REDACTED] showed up [REDACTED] days after the fact he showed up on the [REDACTED] and I have him on tape again today telling me he came right out for that rate well if it happened on [REDACTED] and you showing up on [REDACTED] do he not know how to add and subtract.

This notice of complaint is a request for Internal Affairs to initiate an investigation to determine if the employee conduct is within compliance of APD policy, Civil Service Rules, and Municipal Civil Service Rules.
