### NOTICE OF COMPLAINT

On July 13, 2022, the OPO received an email complaint.

**The complainant alleges:** [REDACTED] should not be contacting me with so-called welfare checks. ADP should not be contacting me with so called welfare checks.

i sent an email (see attached) regarding [REDACTED] playing politics with my application for food and clothing and nearly immediately received a call from [REDACTED] regarding a "welfare check".

i should not be economically marginalized - i am because of [REDACTED] corruption, city of austin, APD, etc.. Consequently, I am dependent on resources provided by corrupt local entities.

you can hear the call here:

[REDACTED]

nope.

this is not the appropriate response.

this is the agenda to benefit [REDACTED] - who i would not have an affair with at his [REDACTED] timeshare.

[REDACTED] is predatory in their responses to me, as is APD, and the city of austin.

i do not need a welfare check. there is nothing wrong with me.

there is something wrong with you.

[REDACTED] the city of austin, and APD are some of the government entities that are helping frame me as an emotionally disturbed person when i am not.

you can see the attached complaint i filed with the commission on jail standards against [REDACTED] and [REDACTED] when i was wrongfully arrested for assault.

█ and █ █ populated my "unit" with █ actors there to harass and torture me.

they put an individual in the cell below me who yelled all day and night "they don't like you. they really don't like you"

█ also instructed the jailer to walk around outside my cell while i was waiting to hear regarding receiving a Personal Recognizance Bond - to yell "false hope! false hope! false hope!" █ subsequently refused to release the employee's name and badge #.

this is unacceptable conduct on the part of █

i have applied for an injunction against the APD for asking █ to call regarding "welfare checks".

it has not been responded to.

█ just contacted me and refused to provide transportation for me to go to the █ █

she said █ doesn't do this.

yes it does.

i know from personal experience. █ social workers drive all over the place do anything at all.

this response is another type of maliciousness on the part of █ to harass me on behalf of █.

this is █ again targeting me and making up operations policy with malicious intent directed at me.

this is not acceptable.

who knows the extent of the fraud being perpetuated by local government and law enforcement.

█ - as in █ and we're going to hunt you down.

who knows if these are even real people or fake names altogether.

i put nothing past you people in terms of your mendacity.
