## NOTICE OF COMPLAINT

On August 4, 2022, the OPO received an email complaint.

**The complainant alleges:** RACIST AUSTIN POLICE PIGS: I will call the Austin police who act like racist gangbanger-thugs with badges “PIGS” every time they violate my civil and constitutional rights and their oaths to uphold the Constitution of the State of Texas as well as the U.S. Constitution. The white RACIST PIG FEMALE COP who drove SUV # [REDACTED] is UNETHICAL TRASH – a DISHONORABLE PIG! Her accomplices in SUV # [REDACTED] are both UNETHICAL TRASH and RACIST PIGS!

[REDACTED] [REDACTED] [REDACTED], from about [REDACTED]. CST to about [REDACTED]. CST, the white female RACIST PIG who drove SUV # [REDACTED] stalked me from [REDACTED] to [REDACTED] down [REDACTED]. This RACIST PIG and UNETHICAL TRASH changed directions to stalk, troll, surveil, and racial profile me at least five (5) to six (6) times. The RACIST PIG aimed her SUV at me while she was still in motion and caused me immediate, severe, and immense fear for my personal safety and my life. I would walk about 70 yards to 100 yards in one direction and the WHITE RACIST TRASH – a DISHONORABLE PIG – would pass slowly in the same direction gawking at me and playing with her computer. Immediately, I would make a U-turn and walk about 200 to 300 yards slowly in the opposite direction, which forced the WHITE RACIST TRASH and DISHONORABLE PIG to have to make a U-turn along [REDACTED] or shoot through the [REDACTED] parking lot to change course. When this PIG would catch up to me in the opposite direction, I would again make a U-turn and walk in the opposite direction. Doing this caused the RACIST PIG – WHITE TRASH COP – to change her course of travel at least five (5) to six (6) times alone [REDACTED]. She even once traveled west along [REDACTED], turned left (south) on [REDACTED], and turned left into the [REDACTED] parking lot to rush to try to get me in front of her police SUV. I made a U-turn and headed back towards the [REDACTED] bridge, westbound. The WHITE RACIST TRASH – DISHONORABLE PIG – did not follow, so I thought. But when I made another U-turn to continue in my original goal and direction, headed eastbound on [REDACTED] [REDACTED] towards [REDACTED] before I could walk about 200 yards, two football fields approximately, there was the WHITE RACIST TRASH – DISHONORABLE PIG – in her SUV # [REDACTED] driving towards my direction on the opposite side of [REDACTED] and

gawking at me as she drove by. The RACIST PIG was threatening and intimidating me – causing me to fear for my immediate safety and life.

I called 911 and I called 911 every time thereafter the WHITE RACIST TRASH – DISHONORABLE PIG – in SUV # [REDACTED] drove alone side of me, slowed down, and gawked at me

During the same time that the WHITE RACIST TRASH – DISHONORABLE PIG – in SUV # [REDACTED] racial profiled, stalked, surveilled, trolled, and threatened my safety and life, a second police SUV # [REDACTED] was aiding and abetting the WHITE RACIST FEMALE TRASH – DISHONORABLE PIG – in SUV # [REDACTED] SUV # [REDACTED] carried to RACIST and DISHONORABLE POLICE PIGS – both males! This POLICE TRASH – POLICE PIGS – also racial profiled, stalked, surveilled, trolled, and threatened my safety and life down [REDACTED] from about [REDACTED], as I was on the public sidewalk but in front of [REDACTED] to the corner of [REDACTED]. The two-male POLICE TRASH – POLICE PIGS – passed and gawked at me to cause me immediate fear for my safety and life three (3) times. From in front of [REDACTED] to [REDACTED] is not a long distance and the two-male POLICE TRASH – POLICE PIGS in SUV # [REDACTED] – had to complete multiple U-turns along [REDACTED] and or through [REDACTED] parking like to do that. While I stood on the corner of [REDACTED] and [REDACTED] on its northbound side, the two-male POLICE TRASH – POLICE PIGS in SUV # [REDACTED] – being on [REDACTED] made a left turn and headed northbound on [REDACTED]. But before I could get the walk light to cross over to the eastside of [REDACTED] the two-male POLICE TRASH – POLICE PIGS in SUV # [REDACTED] – had made a U-turn and headed southbound on [REDACTED] so that they could cross my path and gawk at me to threaten and intimidate me and to cause me to fear for my personal safety and life.

RACIST AUSTIN POLICE PIGS: I will call the Austin police who act like racist gangbanger-thugs with badges “PIGS” every time they violate my civil and constitutional rights and their oaths to uphold the Constitution of the State of Texas as well as the U.S. Constitution.

LITIGATION HOLD: Austin Police is hereby put with NOTICE OF A LITIGATION HOLD to collect, hold, and preserve the GPS tracking records of both SUV # [REDACTED] and SUV # [REDACTED] on [REDACTED].
