<p>Complaint:</p> <p>On Saturday September 20th, 2025, shortly before 9 PM, someone claiming to be with "Guest Services" tried to break into my hotel room at the Holiday Inn at Town Lake. I was nearly asleep when I heard something at my door. When I got up to look, I saw something that looked like a long wire coat hanger underneath my door. I grabbed it trying not to panic and held on tight. It was ripped out of my hands and tore the skin off of my left pinky finger. I started yelling and banging on the wall to the next room saying someone was trying to break into my room when I grabbed my phone and called 911 at 8:48 PM exactly. I don't remember the names of the officers but on may have been McHenry or something similar. He was the one I spoke to. He laughed when I asked for EMS to help me with my injuries and kept trying to take my phone when I was on a speaker phone call with my friend and advocate Carrie Harney. The officer did not ask the guest services man if he had a key card or called my room or cell phone prior to trying to break into my room. The officer said that the hotel needed me to change rooms because another guest was checking in.</p> <p>This should have been treated as an attempted breaking and entering and assault. I had to drop out of my fall college semester because I have PTSD from this incident. I can't remember my hotel room number and haven't been able to make this complaint until now. I was at the hotel for a work-related training conference and was missed the last day because of this.</p> <p>I need documentation of this incident for my school records to so I can continue my education. Case numbers and related information would be helpful.</p>

Box 689001  Austin, TX 78768-9001</p> <p><b>Re: Formal Complaint for Investigative Negligence and Request for Compliance with Legal Investigative Duties</b>  Incident: Hit-and-Run – October 26, 2024  Victim: [REDACTED]  Officer Assigned: <b>Officer Eric Bauer</b>  To Whom It May Concern:</p> <p>I, [REDACTED] submit this formal complaint regarding the inadequate investigation of the hit-and-run incident that occurred on <b>October 26, 2024</b>, in Austin, Texas, in which my daughter and I sustained direct injuries. This letter outlines the legal obligations imposed on responding officers and investigative personnel, and explains how those obligations were not met in this case.</p>	
<p><b>I. Background of the Incident</b></p> <p>On October 26, 2024, I was involved in a collision caused by a driver who fled the scene. The at-fault vehicle was abandoned and later recovered by the police. The registered owner was identified, and the vehicle was determined to be <b>uninsured</b>. My daughter and I suffered physical injuries requiring medical treatment.</p> <p>Despite my cooperation and the existence of physical evidence, no meaningful investigative steps were taken to identify the suspect or hold the responsible party accountable.</p>	
<p><b>II. Legal Duties of Law Enforcement in Hit-and-Run Investigations</b></p> <p>Texas law and departmental policies impose specific obligations on police officers when responding to and investigating hit-and-run cases, including but not limited to:</p>	

### **1. Duty to Conduct a Complete and Thorough Investigation**

Under **Texas Code of Criminal Procedure Art. 2.13**, officers have a legal obligation to:

- "preserve the peace,"
- "detect, suppress, and prevent crime," and
- "file proper charges when authorized by law."

A hit-and-run with injuries constitutes a criminal offense requiring mandatory investigative actions.

### **2. Mandatory Investigation of Failure to Stop and Render Aid**

The driver's conduct constitutes **Failure to Stop and Render Aid** under **Texas Transportation Code § 550.021**, a serious offense that requires:

- identifying the driver,
- questioning the registered owner, and
- reviewing evidence from the scene.

### **3. Duty to Identify and Interview the Registered Owner**

When a vehicle is abandoned at a crime scene, Texas courts repeatedly affirm that officers must conduct a **reasonable owner-witness inquiry**. This includes:

- contacting the registered owner,
- documenting attempts to reach them,
- verifying who had custody of the vehicle at the relevant time.

Failure to perform these steps violates standard investigative protocols.

### **4. Duty to Review Evidence and Technological Tools**

Texas Transportation Code § 550.041 authorizes law enforcement to obtain and review:

- surveillance video,
- bodycam footage,
- vehicle records,
- and available forensic evidence.

When a victim notifies police of potential sources of evidence (such as the use of cellphone tracking), officers are obligated to evaluate those leads.

### **5. Duty to Document and Communicate with Victims**

Under **Texas Crime Victims' Rights (Code of Criminal Procedure Chapter 56)**, victims have the right to:

- receive timely updates,
- request and obtain information regarding the status of investigations,
- and have law enforcement perform due diligence in identifying suspects.

Failure to return calls, provide a case number, or follow up violates these statutory rights.

## **III. Failures Observed in This Investigation**

The following investigative duties were not fulfilled:

- No documented attempts to interview the registered owner of the vehicle.
- No review of available surveillance or technological evidence.
- No issuance of citations for operating an uninsured vehicle.
- No forensic evaluation of the abandoned vehicle.
- No updates to the victim and no provision of a case number.
- No referral to a hit-and-run unit or investigator.

Additionally, the registered owner allowed the vehicle to be operated **without mandatory liability insurance**, in violation of **Texas Transportation Code § 601.051**, and the vehicle was actively being used on public roads at the time of the crash. Operation of an uninsured vehicle is a citable offense under **Texas Transportation Code § 601.191**, and the failure to investigate or cite this violation further demonstrates investigative neglect. These omissions constitute **investigative negligence** and violate the duties described above.

#### **IV. Formal Request for Corrective Action and Documentation**

I respectfully request the following:

1. **Immediate provision of the official case number** for my incident.
2. **Reassignment of the case** to an investigator specializing in hit-and-run offenses.
3. **Written explanation** for the failure to follow mandatory investigative procedures.
4. **Full release of all reports and documentation** under the Texas Public Information Act.

#### **V. Conclusion**

As a victim of a serious crime, I am entitled to a complete and lawful investigation. I request that this matter be addressed promptly and in full compliance with the Texas Code of Criminal Procedure, Departmental policies, and all applicable state laws.

The grandmother was upset, and the neighbor did their best to console her.</p> <p>The neighbor called the complainant some time later saying they could hear yelling and screaming. The neighbors suggested she call the police.</p> <p>She called ██████████ to ask for a welfare check, and they routed her to APD. She told the dispatcher this whole story. They said they would send an officer to the house. The complainant asked that the officer not disclose that it was her who called the police, the dispatcher said of course.</p> <p>Later that evening, she got a call implying that the mother did know it was her who called. She got ahold of the officer who went out. He told her that the mother came out to talk to her, told him it was a misunderstanding and the officer didn't check or even lay eyes on the grandmother who is the homeowner.</p> <p>She asked him directly if he told her mother she was the one who made the call. He insisted he did not, which the complainant does not believe is true. She doesn't feel like he did a full welfare check, and he lied to her about disclosing that it was her who called. <p><b>Complaint:</b></p> <p>First encounter was at [REDACTED] My 3rd attempt to file domestic violence on abuser. I emailed online with all my proof of break ins and getting physically assaulted by my ex boyfriend. Due to him having restriction on my phone. I emailed 10/2025 with all the pictures and proof of abuse. I was then told I was denied, only chance I had then to call was December 20,2025 I called in the morning, apd didn't reach me until 3 hours later by that time I had already left because my abuser was following and chasing me. I wasn't able to call again until 2-3 am at the location I gave on top. Police seen my bruises and scratches on my neck, abuser was inside hiding because his brother works at the location and resides in the attic of establishment. Police were in a rush, black female officer was very rude by telling me I better not go back to abuser because all the women that call apd drop the charges. Due to my mental already being triggered I started to shut down that causes me to not be responsive, I forget things that are important, apd kept asking me the same question over and over that's a trigger for me. I felt like I was not being treated equally. 2nd encounter I feel asleep at Mc donalds on airport 2 officers rudely interacted with me. They did give me there name and badge number but it feel out my pocket when I left. I called 311 and explained if I could get their names. I wasn't able to. I feel asleep there because I can't stay at my own apt. My abuser stole my phone, house keys, all my make up, my shoes, purses, my identification and my bus pass. I'm scared of my life I've stressed this to the officer. I have no where to go but be on the streets until apd catches him. I called 911 today I give abuser home address.. 10289 was very confusing as to the information she was telling me. She said I couldn't do that because I wasn't being assaulted at the time. I said then how come I called almost 2 weeks ago because he's been going to [REDACTED] Police got there in 5 minutes, when they pulled up abuser was n the parking lot and police didn't do their job because he got away again Apd does nothing to help women dealing with domestic violence they treat us as it's our fault, they talk to us like we don't matter. They don't come to us fast enough. This is why women end up back with abuser or dead. I still haven't had a detective call or reach out to me. I've been walking the streets because I can't go home until he's in jail. I'm scared of my life, I have no help especially from Apd who is to protect and serve. Shelters are full to compacity crimes victims services is taking forever as well. I'm trying to stay alive not be another statistic. Abuser caused me to have my baby 6 weeks early from physical abuse, Im lucky I made it out alive and running away to get help and this is how I've been getting treated.</p>

<p>Complaint:</p> <p>The complainant alleges:  Dear Austin Police Department Leadership, Chief of Police, Internal Affairs, and Relevant Authorities,  I am writing to place the Austin Police Department (including all operations, offices, employees, systems, facilities, and affiliated entities) on formal and immediate notice of an active, multi-state criminal enterprise operating continuously since approximately 2018 across Arizona, California, Texas, Colorado, Florida, and Nevada. This enterprise involves conduct constituting racketeering under the Racketeer Influenced and Corrupt Organizations Act (RICO), 18 U.S.C. §§ 1961–1968. RICO has been successfully applied to public corruption schemes involving government employees in both Texas and California, establishing precedents for its use against association-in-fact enterprises engaging in patterns of bribery, fraud, and related predicate acts. In Texas (Fifth Circuit), notable cases include <i>United States v. Garcia et al.</i> (W.D. Tex. 2013), where former El Paso County officials and affiliated individuals were convicted of RICO conspiracy for a pay-to-play contract scheme involving bribery and mail fraud; and <i>United States v. Ramirez et al.</i> (S.D. Tex. 2024), in which Texas Department of Criminal Justice correctional officers pleaded guilty to RICO conspiracy for contraband smuggling facilitated by bribes. In California (Ninth Circuit), key precedents encompass <i>United States v. Huizar et al.</i> (C.D. Cal. 2020–ongoing), resulting in convictions for RICO conspiracy in a Los Angeles City Council pay-to-play bribery scheme; and <i>United States v. Chan</i> (C.D. Cal. 2024), affirming RICO liability against a former Los Angeles deputy mayor for honest services fraud and related acts. These cases illustrate RICO’s efficacy against high-level public sector employees, requiring proof of an enterprise, predicate acts (e.g., bribery under 18 U.S.C. § 201, mail/wire fraud under 18 U.S.C. §§ 1341, 1343), and a pattern with continuity (per <i>H.J. Inc. v. Northwestern Bell Telephone Co.</i>, 492 U.S. 229 (1989)). Additional conduct includes repeated false reports of emergencies under 18 U.S.C. § 1038; large-scale unauthorized disclosure of personal information under the Computer Fraud and Abuse Act (CFAA), 18 U.S.C. § 1030 (as interpreted in <i>Van Buren v. United States</i>, 593 U.S. 374 (2021)); distribution and threatened distribution of child sexual abuse material under 18 U.S.C. § 2251; elder abuse under the Elder Justice Act, 42 U.S.C. § 3058i, and state analogs; tax fraud under 26 U.S.C. § 7201; bank fraud under 18 U.S.C. § 1344 (as clarified in <i>Loughrin v. United States</i>, 573 U.S. 351 (2014)); insurance fraud under 18 U.S.C. § 1033 (as in <i>United States v. Saadey</i>, 393 F.3d 669 (6th Cir. 2005), involving false entries in insurance records); immigration fraud under 18 U.S.C. §</p>	

1546; unauthorized access under CFAA, 18 U.S.C. § 1030; conspiracy against rights under 18 U.S.C. § 241; obstruction of justice under 18 U.S.C. § 1505 (as in *United States v. Aguilar*, 515 U.S. 593 (1995)) and 18 U.S.C. § 1503 (as in *United States v. Cintolo*, 818 F.2d 980 (1st Cir. 1987)); witness tampering under 18 U.S.C. § 1512 (as in *Arthur Andersen LLP v. Coss*, 677 F.3d 278 (6th Cir. 2012)), 18 U.S.C. § 2261A (stalking, as in *United States v. Sayer*, 748 F.3d 425 (1st Cir. 2014)), state defamation laws such as Texas Civil Practice and Remedies Code § 73.001 (as in *New Times, Inc. v. Isaacks*, 146 S.W.3d 144 (Tex. 2004)), and 18 U.S.C. § 245 (federally protected activities, as in *United States v. Substantial evidence of these offenses exists, including documented incidents, perpetrator self-identifications, and reports submitted to federal authorities. This criminal conduct directly involves Austin Police Department operations, offices, employees, systems, or facilities, including unauthorized access to data or facilities, coordination of doxxing and swatting, insider misuse of information, dissemination of false claims, and potential complicity in harboring criminals or obstructing inquiries. The criminal conduct has caused material and ongoing harm to my professional opportunities and operations, including repeated sabotage and blackballing disrupting employment; interference with professional networks; business disruptions and increased liabilities; credit score deterioration; personal injuries; property damage; interference with employment candidacies in Texas entities; and interference with monetary rewards tied to tips offered by government agencies. Criminal acts were committed against me in various locations across the aforementioned states, with connections to Austin Police Department entities. Years of Warnings to Perpetrators: Over the past several years (dating back to at least 2023), I have issued repeated warnings directly to the identified criminals—through documented communications, public notices, and reports to authorities—regarding the severe consequences of their actions, including federal indictments, lengthy prison sentences, civil liability, and professional ruin.

Despite these warnings, the perpetrators have persisted, further implicating the Austin Police Department. Proof of these warnings has been preserved and shared with investigating agencies. In pending and forthcoming litigation, the Austin Police Department should anticipate subpoenas and litigation hold demands for relevant records.

I have submitted detailed reports and proof to federal authorities, with ongoing discussions. The scope, duration, documented reporting, national-security implications, and direct involvement of Austin Police Department entities demand immediate internal investigation, evidence preservation, and risk-mitigation actions.

My report specifically alleged that the booting company did not possess the required authorization from the Texas Department of Licensing and Regulation (TDLR) to engage in vehicle booting, rendering the immobilization unlawful under Texas Occupations Code Chapter 2308.</p> <p>APD's subsequent response—issued by Wrecker Enforcement—states that “complaints of this nature are handled through a civil process” and summarily closes the report with no further action. This response fails to address the substance of the complaint and reflects a material misunderstanding of the allegation presented.</p> <p>My complaint did not concern a routine civil dispute over towing fees or consumer dissatisfaction. It alleged that an unlicensed entity engaged in regulated booting activity and collected money under color of authority it did not lawfully possess. Under Texas law, operating as a booting company without proper licensure is not merely a civil issue; it constitutes unlawful conduct, and the collection of fees under such circumstances may satisfy the elements of criminal fraud and theft by deception.</p> <p>At no point did APD:</p> <ul style="list-style-type: none"> <li>• Verify the booting company's licensing status with TDLR</li> <li>• Assess whether the boot was placed by a legally authorized operator</li> <li>• Analyze whether the demand and collection of payment constituted a criminal offense</li> <li>• Contact me for clarification or additional evidence</li> <li>• Provide a legal rationale for declining jurisdiction over alleged unlawful conduct</li> </ul> <p>Instead, APD issued a generic consumer-guidance response unrelated to the actual allegation, effectively refusing to investigate whether a crime occurred. Referring a complainant to TDLR or</p>	

a Justice of the Peace does not absolve APD of its obligation to evaluate credible allegations of criminal conduct, particularly where statutory violations are expressly alleged.

This failure raises serious concerns regarding:

Whether APD personnel are improperly categorizing allegations of unlicensed booting and fraudulent fee collection as purely civil matters.

Whether APD policy is being followed when a report alleges conduct that is criminal per se if statutory licensing requirements are absent.

Whether similar complaints are being routinely closed without investigation, creating a de facto enforcement gap.

I respectfully request that Internal Affairs conduct a review of the handling and closure of Report No. [REDACTED], including supervisory oversight of the decision to take no action. I further request a written explanation identifying the legal basis upon which APD determined that the alleged conduct could not constitute a criminal offense.

This complaint is submitted in good faith and with the expectation that APD adheres to its duty to investigate alleged criminal activity, particularly when it involves regulated industries and vulnerable populations, including disabled veterans.

Because the sticker uses harsh, explicit language and expresses an aggressive political message, it undermines the purpose of the wellness program and the sense of neutrality and safety that should exist in that space. COA policy on political activities in the workplace prohibits the display or use of City positions, resources, or influence to promote political viewpoints while on duty or in the work environment. Although the sticker is on a personal vehicle, its continual presence at a City worksite—especially attached to a department leader charged with implementing "Wellness"—reasonably appears as political advocacy in the workplace and is inconsistent with COA standards of conduct, professionalism, and respect.</p> <p>Several officers have expressed that the message makes them uncomfortable and reluctant to approach or confide in the Wellness Director. Officers seeking help are often in vulnerable situations, and they are supposed to feel supported rather than exposed to explicit profanity and political hostility. The sticker conveys anger and bias, which conflicts with the director's role and discourages open communication. This has directly affected the effectiveness of the wellness initiative and the trust officers place in that office.</p> <p>I respectfully request that the City review this matter for violation of COA political-activity policy and standards related to respectful workplace behavior. No evidence review or inquiry was conducted. Phone call from APD Crisis Unit: January 7, 2026 – No investigative discussion occurred. After receiving the suspension notice, I submitted additional documentation via certified mail, yet no APD representative engaged in any investigative steps or communication regarding my complaint.</p> <p>III. Civil Rights and Oversight Concerns Failure to Investigate Complaints APD suspended my harassment complaint without any follow-up, documentation, or request for clarification, denying access to investigative services. Pattern of Non-Response Over multiple years, my prior complaints to APD have either been ignored or redirected toward unrelated matters (e.g., my mental health history) instead of addressing the harassment allegations. Impact on Access to Legal Remedies The lack of investigation prevents me from pursuing legal protections, retaining counsel, and asserting my rights. **VI. Closing**

The repeated failure of APD to investigate harassment and interference has left me without access to protective services or recourse. I submit this complaint in good faith and request a full review by the Office of Police Oversight.

These actions have affected my ability to work, communicate, exercise civil liberties, and safely participate in society.</li> <li><b>Initial Reporting to Austin Police Department (APD)</b> I attempted to report these events to municipal law enforcement. I filed an APD case report (Case # if available). On November 20, 2023, I received a written email response from the APD Criminal Investigations Division (CID Team II), attached as Exhibit A. APD informed me that: "This is not a municipal law enforcement issue if federal agencies are involved... There is nothing the Austin Police Department can do to assist you on such a matter." APD also recommended "following through with a lawyer" instead of offering any investigative remedy. APD simultaneously dismissed the complaint as lacking credibility due to its subject matter rather than evidence or inquiry. At no point did APD investigate, interview me, or offer referral to any public agency capable of handling federal-level civilian interference claims.</li> <li><b>Attempt to Use Local Oversight: Office of Police Oversight (OPO)</b> Because APD refused to investigate, I sought accountability through the Austin Office of Police Oversight (OPO) — the city-designated civilian oversight mechanism. The intended purpose of OPO is to provide independent oversight, ensure accountability, and process police misconduct or service complaints for residents who are denied police protection or treated unfairly. However, when I contacted OPO: My complaint was not substantively reviewed No remedial action was taken No investigation was initiated No referral to an appropriate authority was provided If you provide details or documents from OPO, we can specify them here. For now, we document the failure structurally:</li> </ol>	

Structural oversight failure: OPO is an administrative mechanism designed to ensure accountability after APD refuses service. In my case, the oversight mechanism failed at the intake level, creating a complete denial of access to law enforcement accountability within the city government.

4. Combined Effect: No Municipal or Oversight Remedy Available

The result of APD + OPO denial is:

No police investigation

No civilian oversight review

No municipal remedy

No administrative remedy

No due process pathway

This is significant because federal civil rights doctrine considers the denial of access to police services and oversight as a deprivation of rights under color of law, particularly when it affects safety, equal protection, and participation in society.

5. Civil Rights Implications for DOJ Review

The pattern described implicates multiple constitutional rights:

A. Fourteenth Amendment – Due Process

Both APD and OPO denied me procedural pathways for investigation, reporting, or remedy.

B. Fourteenth Amendment – Equal Protection

Denying police services based on subject matter or perceived credibility, without investigation, is a form of arbitrary denial of protection.

C. First Amendment – Right to Petition Government

Attempts to report wrongdoing and seek redress were met with non-response and dismissal, constituting potential retaliation or obstruction.

D. 42 U.S.C. §1983 – Deprivation of Rights Under Color of Law

Municipal actors refused to perform basic police service functions and denied oversight access.

6. Federal Involvement Assertion

APD explicitly referenced the involvement of federal agencies. If true, this suggests potential federal action against a civilian without:

Disclosure

Due process

Judicial oversight

Notification

Remedy

This places the matter squarely within DOJ jurisdiction, independent of local failure.

7. Harm and Impact

Since July 2022, these failures have resulted in:

Employment interference

Communication interference

Social and psychological harm

Financial and professional damages

Ongoing safety concerns

Loss of confidence in local remedies

Civil participation chilling effects

8. Relief Requested

I respectfully request that the DOJ Civil Rights Division:

- Investigate potential federal involvement affecting civilian rights.
- Determine whether APD's refusal constitutes denial of police services.
- Determine whether OPO's failure constitutes denial of access to oversight.
- Identify any federal agency involved and require due process compliance.
- Provide direction for further remedy if jurisdiction extends to other DOJ components.

These are not merely wage disputes, and they were not submitted as such. The categorization in the detective's email does not reflect the content of my report.</li> <li><b>**The report was suspended without investigation, follow-up, or requests for clarification.**</b> At no point did APD contact me to obtain additional detail, documentation, or clarification before suspending the case. There was no attempt to determine whether criminal behavior (stalking, interference, harassment, or coercion) might be present.</li> <li><b>**There is a documented pattern of APD receiving my complaints and failing to investigate.**</b> Over the past several years, I have made multiple complaints to APD regarding ongoing interference and harassment. At least one prior officer indicated that an investigation would be initiated, yet I have never received findings, updates, or guidance.</li> <li><b>**Failure to investigate has resulted in real harm and lack of access to remedies.**</b> The interference I reported has affected my employment, access to legal counsel, and attempts to seek assistance through official channels. Suspending complaints at intake effectively prevents these harms from being documented or addressed.</li> <li><b>**I am requesting transparency, accountability, and proper handling.**</b></li> </ol>

<p><b>Complaint:</b></p> <p>I am writing to request an investigation in response to the media reports this week that on Monday, January 5, 2026 at about 4:35 a.m., APD officers responded to a call off of Blue Stem Trail, notified ICE that a woman at the scene was undocumented, and detained her and her 6 year old daughter, a U.S. Citizen, until they could be taken into custody by ICE. See, e.g., KXAN, "ICE takes mom, child into custody after Austin police notifies agents," available at <a href="https://www.kxan.com/news/local/austin/ice-takes-mom-child-into-custody-after-austin-police-notifies-agents/">https://www.kxan.com/news/local/austin/ice-takes-mom-child-into-custody-after-austin-police-notifies-agents/</a> This incident created widespread alarm in the community after the family was unable to locate the 6 year old or get information from ICE about where she could be found, for a few days.</p> <p>According to APD representative Anna Sabana, as reported by KXAN, the officers did not find an "on-going disturbance" or anyone with injuries, but "identified an individual with an Administrative Warrant issued by [ICE]."</p> <p>Contacting ICE to report an undocumented person and detaining her until she could be taken into custody by ICE, in response to an Administrative Warrant, rather than a Detainer Warrant, is a violation of APD General Order 330.7.1(a) and (c). The circumstances of this incident also call into question whether the officers violated GO 330.4 governing inquiries into a person's immigration status.</p> <p>Although I do not have personal knowledge of the facts of this incident, as a long-time Austin resident and Texas lawyer, I find this incident alarming and urge you to investigate it promptly and fully. I reported these incidents to the Austin Police Department on 12/15/25, and a detective was assigned to the case. Ongoing incidences of the threats were reported in addition to the original threat.</p> <p>Despite the seriousness of the allegations and the fact that the victim is a minor, I did not receive any follow-up for four weeks. I only heard back after I repeatedly called and emailed the assigned detective. And only the one correspondence. At that time, I was informed that the matter constituted "harassment" described as a Class C misdemeanor, and that I would need to pursue the case independently in municipal court. After consulting with a licensed attorney, I was advised that terroristic threat under Texas Penal Code 22.07 is a Class B misdemeanor, and that threats involving death or serious bodily injury - especially towards a minor - warrant investigation and potential criminal charges as determined by police investigation and prosecution. I communicated this by voicemail to the detective assigned to this case.</p> <p>I am deeply concerned that my daughter's safety has not been adequately addressed and that the case may have been incorrectly characterized or prematurely dismissed without proper investigation. Given the repeated nature of the threats, the involvement of multiple individuals, and the age of the victim, I believe this matter warrants immediate review.</p> <p>I am requesting the following:</p> <ol style="list-style-type: none"> <li>1. A formal review of how this case was classified and handled</li> </ol>	

2. Clarification as to why a terroristic threat involving a minor was redirected to municipal court
3. Reassignment of the case, if appropriate, to ensure a proper and timely investigation
4. Written confirmation of the next steps being taken to protect my child

Please consider this email a formal complaint and request for supervisory review. I am asking for a response within a reasonable timeframe, as this situation directly impacts my child's safety and well-being.
